8 CCG Updates

The 4 CCGs have agreed to merge to form 'Berkshire West CCG'. There will still be 4 localities represented by 1 GP rep from each area. The structure of the new CCG is still to be decided. The premise behind this and the ACS 'Accountable Care System' is to bring the healthcare provision in Berkshire West together in a joined up fashion. The GPs in Wokingham have also formed a company - the Alliance - so they can be represented in this new structure.

The patients probably won't notice a huge amount of difference to start with, but one of the aims is to enable patients to be seen closer to home rather than having to travel to the hospitals. GPs are also being encouraged to federate or join together to form larger practices. This will be of benefit for extended hours access and 7 day working which the government is proposing. There aren't enough GPs around so sharing the burden is the only way to go.

Roger had a query regarding EPS - EPS is for non dispensing patients and enables us to send their script electronically to their nominated chemist. For safety reasons it is better for patient to have all their prescriptions filled in one location.

Occasionally, if we do not have a particular drug in stock or are unable to get it, we do have to give our dispensing patients a script to take away to a chemist. This would be a one off occurrence and doesn't mean that that patient will then never be able to have their prescriptions dispensed at Swallowfield.
